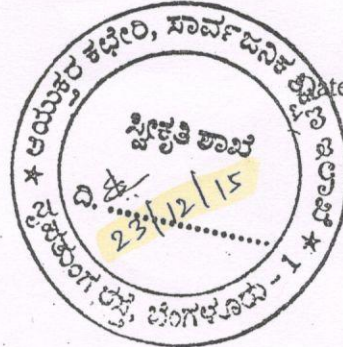

THE GEMS EDUCATIONAL TRUST, SIRA manages "The Presidency Public School," Sira, which is a permanently unaided institution, recognized by Government of Karnataka. It is a parent funded institution running classes from 1 to 10 in English medium, under the State Board syllabus since 2002.

We would like to submit to your good self that during the last few years, there has been continuous demand from parents for providing CBSE pattern of education to their wards studying in our School. The main plea put forth by them in this regard is that CBSE syllabus is more advantageous for their wards while appearing for various competitive entrance examinations for higher education courses. Keeping in view the demand of the parents and also considering the career aspirations of our students, the Governing Body of the School at its meeting held on the 6<sup>th</sup> January, 2014 resolved to seek affiliation of the School with CBSE up to secondary level, on switch over basis. Accordingly, the School submitted its application to the office of the CBSE on 26.6.2014 for provisional affiliation up to secondary level on switch over basis as per the CBSE guidelines.

It is further submitted that once affiliation is granted, the State pattern classes will be switched over to CBSE pattern in a phased manner and the concerned staff & teachers will get absorbed in the same CBSE School as a natural process of transition.

Sub:- Amendment in affiliation Bye-laws Rule 3.3(I) chapter II-reg.

Sir/Madam,

Consequent upon recommendations of the Affiliation Committee made in its meeting held on 24.06.2013 and subsequently approval of the Governing Body of the Board in its meeting held on 28.06.2013, the following amendment in affiliation Bye-laws of the Board has been made by the Board:

Existing Rule 3.3 (I) chapter II	Amended Rule 3.3 (I) chapter II
The school seeking provisional affiliation with the Board must have formal prior recognition of the State/U.T. Govt. Its application either should be forwarded by the State Govt. or there should be a No Objection Certificate to the effect that State Government has no objection to the affiliation of the school with the CBSE. "No Objection Certificate" once issued to any school will be considered at par even if it prescribes a specific period of *stage unless it is withdrawn. Condition of submitting a No Objection Certificate will not be applicable to categories 3.1(i) to (iv)	The school seeking provisional affiliation with the Board must have formal prior recognition of the State/U.T Govt. and also to produce evidence to this effect that the applicant school had intimated to the concerned Education Department of the State about the application made to CBSE for seeking affiliation with the Board. In case, the Board receives any objection during the process of application of the school, the Board may ask the concerned school to produce the No Objection Certificate from the State Government or otherwise it would be assumed that concerned State/U.T. Government has No objection.

The above amendment is brought to the notice of all concerned.
